THE CHALLENGE

Peter Fox totalhealth Pharmacy is an Irish independently owned and community-based pharmacy in Birr, Co. Offaly. The pharmacy, which is part of the totalhealth Pharmacy group, has been serving the health needs of the local community for over 80 years. Peter and his wife Patsy have been running Peter Fox Pharmacy since 1994.

Peter Fox wanted to find a solution to minimise cash handling from the start to the end of the business day. The pharmacy is open 6 days a week, 9 hours a day, employing several staff across different shift patterns. Therefore, there was a business requirement to automate certain processes, such as cash management. Cash handling processes can be labour intensive, and the pharmacy wanted to improve on processes such as:

- Save time on the making up of floats
- Reduce time for reconciliation at the end of the day
- Eliminate discrepancies in cash handling and counting
- Improve hygiene with staff not handling cash at the point of sale

Other key factors were for the solution to fit easily into the shop layout and be integrated with the pharmacy POS software while allowing for social distancing.
